

## Call for applications of PhD students – 2026 DDEA Summer School for PhD Students

Created in April 2012 by the Fonds de Recherche du Québec – Secteur Santé (FRQ), the mission of the **Cardiometabolic Health, Diabetes and Obesity Research Network** is to pursue the development of research into metabolic and cardiovascular health, diabetes and obesity, and to transfer and mobilize knowledge to promote sustainable health among Quebecers.

The network is calling to take part in the *Danish Diabetes & Endocrine Academy (DDEA) Summer School for PhD Students*, which will take place from **August 24 to 27, 2026** at **Sinatur Hotel Gl. Avernaes, Helnæsvej 9, DK-5631 Ebberup in Denmark** (<https://ddeacademy.dk/events/course/ddea-summer-school-on-diabetes-metabolism-and-endocrinology-for-phd-students-3/>). PhD Student from all regular members of the network are invited to participate in this competition. The objective of this Summer School is to gain knowledge about the newest aspects and developments in the field of diabetes and metabolism at a high level. In addition to attending lectures by leading experts in the field, participants will discuss their own research interests and activities at a high scientific level, meet other PhD students and become familiar with other research projects. The DDEA will cover the local costs (*Summer School registration, meals and accommodation (personal expenses and extended accommodation are not included)*) of the Quebec participants selected by the CMDO Network. The CMDO will pay \$750 per participant to reimburse a portion of the transportation costs. All other costs will be assumed by the participant and/or his/her director.

***Deadline for submitting applications is April 20, 2026.***

Women, Aboriginal people, visible minorities, ethnic minorities, people with disabilities and people from the 2SLGBTQIA+ community are encouraged to apply. For evaluation purposes, we strive to recruit a diverse committee that reflects the profiles of the applicants and ensure an evaluation process that takes into account the particular situations of the applicants, including atypical trajectories.

The eligibility criteria and the evaluation method are described below. Requests submitted late, incomplete or that do not meet the eligibility criteria will not be evaluated. Selected candidates will be contacted no later than **in may**.

### **Eligibility criteria:**

- 1) To be a PhD student, whose research director is a **regular member** of the CMDO Network. The research director must be a member of the network before applying to the competition.
- 2) Have a research project related to diabetes, metabolism or endocrinology.

- 3) Excellence and involvement:
  - Have an excellent academic record.
- 4) Demonstrate a motivation to pursue a research career in one of the network's areas of focus: Cardiometabolic Health, Diabetes and Obesity.
- 5) Speak and understand English (conferences and discussions are in English).
- 6) Selected participants will be required to submit a scientific abstract to this Summer School which will take place from August 24 to 27, 2026 in Ebberup, Denmark (deadline for abstract submission: **May 31, 2026**).
- 7) Please note that doctoral students may only win this competition once. Previous winners are not eligible to participate. However, if their circumstances allow, they may still take part in the activity at their own expense.

#### **Application evaluation process:**

All applications are evaluated by a Scientific Committee. Any member with a conflict of interest is excluded from the final decision. If necessary, an external committee may be formed to carry out the evaluation. Competition results will be announced in the weeks following the application deadline.
